

Music License Agreement

Soundwave Sanctuary Music — Independent Music Label

This agreement sets out the terms on which you may use music from Soundwave Sanctuary Music. It is provided in Thai and English; if the two versions differ, the **Thai version prevails**. It takes effect on the date you complete payment or accept these terms.

1. Parties

Licensor: Soundwave Sanctuary Music (the "Label", "we", "us"), an independent music label based in Thailand. **Licensee:** the individual or company that purchases a license ("you"). By paying, you agree to these terms.

2. Definitions

"Music" means the sound recordings and/or musical compositions owned or controlled by the Licensor that are covered by the plan you purchase. **"Plan"** means the license option you buy — Single Song, Catalog Monthly, Catalog Yearly, or a custom license we issue in writing.

3. Licence granted

We grant you a non-exclusive, non-transferable, worldwide licence to use the Music for the term of your Plan, only as described in Section 4.

- **Single Song** — one track you select at checkout.
- **Catalog Monthly / Yearly** — every track in our catalogue while your subscription is active and paid, including new releases added during that time.

This is a licence, not a sale or transfer of copyright. We retain all ownership (Section 8).

4. What you may do (standard Plans)

- Use the Music, or a cover version you record yourself, in your own social-media content (Instagram, TikTok, YouTube, Facebook, and similar).
- Record and release your own cover version of a licensed song on streaming and social platforms.
- Use the Music as background or featured audio in your non-broadcast online videos.

All of the above require credit as set out in Section 6.

5. What is not included (separate license or quote required)

The following are not covered by standard Plans and must be arranged with us separately:

- Public performance of the songs at concerts, events, or venues (may require clearance through a collecting society).
- Advertising, film, television, video games, or other commercial and sync placements.
- Sampling the Music into a new work released commercially.
- Any exclusive rights, resale, or broadcast rights.

6. Credit

Unless we agree otherwise in writing, please credit the Music in the format: "Music by [Artist Name] — Soundwave Sanctuary", with a link to our YouTube channel where practical. For cover recordings, also credit the original songwriter(s) as required by the platform or collecting society.

7. Restrictions — you may not

- Resell, sublicense, share, or redistribute the Music as a standalone audio file.
- Claim that you wrote, own, or created the Music.
- Use the Music in unlawful, hateful, defamatory, or sexually explicit content.
- Register the Music (or your cover) with any Content-ID or rights-management system in a way that blocks the Licensor, our artists, or other licensees.
- Remove or alter metadata, watermarks, or credits.

8. Ownership

The Licensor, together with its artists and songwriters, retains all right, title, and interest in the Music, including all copyrights and master rights. If you record a cover, you own your new recording, but the underlying composition remains owned by the Licensor or the original songwriter, and your use remains subject to this agreement.

9. Term, renewal, and termination

- **Single Song:** the licence lasts one (1) year from the purchase date.
- **Subscriptions:** valid while your subscription is active and paid, and renew automatically until you cancel. Content you published during an active subscription may remain published after you cancel, but you may not make new uses once the subscription ends.
- We may suspend or terminate this licence if you breach these terms.

10. Fees and payments

Fees are shown at checkout for your selected Plan and are processed securely by Stripe. Subscriptions renew automatically at the then-current price until cancelled. Except where required by law, fees are non-refundable.

11. Warranty and liability

The Music is provided "as is." We warrant that we have the right to license it to you. To the maximum extent permitted by law, our total liability under this agreement is limited to the fees you paid, and we are not liable for indirect or consequential losses.

12. Governing law

This agreement is governed by the laws of Thailand, and any disputes will be handled by the courts of Thailand.
